1. **MR. P. M. MOSANANA, MP. (KANYE EAST):** To ask the Minister of Local Government and Traditional Affairs: (90)
 - (i) if he is aware of the devastating conditions of Mmamongke Health Post; and
 - (ii) what plans are in place to address the situation.
2. **MR. A. K. KHAN, MP. (MOLEPOLOLE NORTH):** To ask the Minister of Water and Human Settlement: (91)
 - (i) to apprise this Honourable House on the status of the pledge to deliver 100,000 houses within the first five (5) years as stated in the 2024 UDC Manifesto:
 - (ii) to indicate what progress, if any, has been made towards this commitment; and
 - (iii) how many houses are allocated to Molepolole.
3. **MR. V. B. PHOLOGOLO, MP. (KANYE WEST):** To ask the Minister of Local Government and Traditional Affairs to brief this Honourable House on the number of butcheries that have been closed for non-compliance with meat hygiene standards in the last three (3) years and what were the main reasons for non-compliance. (92)
4. **MR. S. O. DIGWA, MP (BOTETI WEST):** To ask the Minister of Local Government and Traditional Affairs to update this Honourable House on the timelines, budgetary allocations, and inter-ministerial collaborations being pursued to ensure that citizens in rural communities enjoy the same standard of healthcare access as those in urban centres. (93)
5. **MR. M. BAGAISAMANG, MP. (SHOSHONG):** To ask the Minister for State President to state: (94)
 - (i) how many Directorate of Intelligence Services (DIS) officers were promoted from C1 to E2 in the last five (5) years;

- (ii) if their promotions were in line with the Public Service Act;
- (iii) if it is true that these officers are just staying home yet on DIS payroll; and if so,
- (iv) what remedial action the Minister intends to take to correct this anomaly on promotions.

6. **MR. L. BARONGWANG, MP. (MOGODITSHANE EAST):** To ask the Minister of Transport and Infrastructure to update this Honourable House on the ongoing 27 kilometre Mogoditshane-Mmankgodi dual carriageway; specifically stating the following: (95)

- (i) when the project commenced and the volume of work done against the planned;
- (ii) total amount spent thus far;
- (iii) expected completion date;
- (iv) if the Minister foresees the project being completed on time and on budget considering the progress rate; and
- (v) how much itemized maintenance and traffic management costs to the existing road has already been paid to the contractor; and
- (vi) if the Minister is aware of poor maintenance and traffic management experienced since the tender was awarded.

7. **MR. K. K. KAPINGA, MP. (OKAVANGO WEST):** To ask the Minister of Local Government and Traditional Affairs if he is aware: (96)

- (i) that the project to construct Rwee Primary School in Shakawe has disastrously collapsed;
- (ii) that similar projects in other districts which were commenced at the same time with Rwee Primary School are now operational whilst the latter is far from completion;
- (iii) that even the bricks used for the Rwee project are inferior to those used for example at Diagane Airlink Primary School;
- (iv) if this is not attributable to the budget for Rwee Primary School not having taken into cognisance the astronomical difference in cost of building in Shakawe and other places in or near Gaborone; and
- (v) is there any hope of the school being completed soon.

8. **DR. U. DOW, MP. (KGATLENG WEST):** To ask the Minister of Child Welfare and Basic Education if she is aware of the sorry state of many schools in the Kgatleng West Constituency and more particularly, whether she is aware that: (97)
- (i) Artesia Junior Secondary School, a boarding school of more than 400 students has inadequate toilets for its students, malfunctioning electric system, inadequate food for its students and dilapidated boarding facilities;
 - (ii) Rasesa Primary School has old, smelly, unhygienic pit latrines; and the situation is hardly any different at other schools in the constituency.
9. **MR. T. B. LUCAS, MP. (BOBIRWA):** To ask the Minister of Lands and Agriculture to state the total number of applicants on the waiting list for residential plots in Bobirwa Constituency, Bobonong, Tsetsebjwe, Gobajango and Mathathane: and; (98)
- (i) to apprise this Honourable House on applications for ploughing fields in Botswana and Bobirwa Constituency;
 - (ii) to state the last time business plots were allocated in Bobonong, Selibe Phikwe, Mmadinare, Maunatlala and Lerala; and
 - (iii) if he will consider reviewing the modality for allocating church plots in Botswana.
10. **MR. M. MOALOSI, MP. (NKANGE):** To ask the Minister of Sport and Arts to state: (99)
- (i) the amount of money Botswana National Sports Council (BNSC) disbursed to Botswana Motor Sport (BMS) over the past ten (10) years;
 - (ii) the number of Annual General Meetings (AGMs) that BMS has held over the same period where financials have been presented;
 - (iii) whether it is normal for tax payers' money to be disbursed annually to an organisation that does not account for the said money; and
 - (iv) which AGM minutes were used by BMS for re-registration with the Registrar of Societies since AGMs have not been held regularly.

11. **MR. C. K. JACOBS, MP. (LOBATSE):** To ask the Minister for State President (69) to brief this Honourable House on the need and necessities for the establishment of an open public National Register for Sex Offenders and Office of Information Regulator as a way of safeguarding the nation and maintaining relevance to protect our people in regard to sex crimes; he should further state if he is aware that the National Register:
- (i) is necessary for statistical information and socio-economic development; and
 - (ii) can be used to deter sex crimes, benchmarking and aligning with foreign standards, foreign nations and international organizations against sex crimes and offences.
12. **MR. M. M. MOROLONG, MP. (KGATLENG CENTRAL):** To ask the Minister for State President if he will consider the development of a legal framework that allows for individuals with minor or civil convictions to apply for expungement of finger prints after a period of demonstrated rehabilitation. (86)

- Medicines and Related Substances Bill, 2025 (Bill No. 29 of 2025)

An Act to provide for the continuation of the Botswana Medicines Regulatory Authority whose main objective is to regulate the sale, distribution, importation, exportation, manufacture and dispensing of medicines and related substances; and matters incidental thereto.
